## SECTION-2 INSTRUCTIONS TO THE BIDDERS

### 1. GENERAL INSTRUCTIONS

- 1.1 The sealed bidding documents in two bid system should be delivered in the office of **Director-cum Principal, Rajiv Gandhi Govt. Engineering College, Kangra at Nagrota Bagwan** by the stipulated date and time. Tender Documents may be collected from Office of the Director-cum Principal, RGGE College, Kangra at Nagrota Bagwan on payment of **Tender Cost of Rs.500/-** (Rupees Five Hundred only) through Bank Draft/Pay Order in favor of Director-cum Principal, RGGE College, Kangra at Nagrota Bagwan, payable at Nagrota Bagwan on any working day between 10.00 A.M to 5.00 P.M. before scheduled date and time.
- 1.2 The tender documents may also be downloaded from this office website <http://www.rggec.ac.in> . Those bidders who wish to download the tender documents from the official website should furnish the Tender cost of Rs.500/- through Bank Draft/Pay Order along-with the Bidding Documents and EMD.
- 1.3 While all efforts have been made to avoid errors in the drafting of the tender documents, the bidder is advised to check it carefully. No claim on account of any errors detected in the tender documents shall be entertained.
- 1.4 Each page of the Tender documents must be stamped and signed by the authorized signatory or persons submitting the Tender in token of his/their having acquainted himself/ themselves and accepted the entire tender documents including various conditions of contract. Any Bid with any of the Documents not so signed is liable to be rejected at the discretion of the Client. **NO PAGE SHOULD BE REMOVED/DETACHED FROM THIS BIDDING DOCUMENT.**
- 1.5 All Bidders are hereby explicitly informed that conditional offers or offers with deviations from the conditions of Contract, the bids not meeting the minimum eligibility criteria, Technical Bids not accompanied with EMD of requisite amount/format, or any other requirements, stipulated in the tender documents are **liable to be rejected.**
- 1.6 The requirement of manpower is tentative and may increase or decrease by 25% at the sole discretion of the competent authority of the Client.

### 2. MINIMUM ELIGIBILITY CRITERIA

The following shall be the minimum eligibility criteria for selection of bidders technically.

- a. **Legal Valid Entity:** The Bidder shall necessarily be a legally valid entity either in the form of a Limited Company or a Private Limited Company registered under the Companies Act, 1956 or any other form Registered under law. Bidders in the form of Proprietorship & Partnership are also permitted. A proof for supporting the legal validity of the Bidder shall be submitted.

- b. **Registration:** The Bidder should be registered with the Income Tax Deptt., Employees Provident Fund Organization (EPFO), Employees State Insurance Corporation(ESIC) etc. and other related obligatory registrations as per law. The bidder shall get proper Labour Registration/License from Labour department *within 1<sup>st</sup> quarter* (three months) of receiving the supply order.
- c. **Clearance/Affidavit:** The Bidder should also have clearance from Sales/Service Tax Department, and Income Tax Department.
- d. **Experience:** The Bidder should have experience in the similar field of providing manpower in similar services in the Govt./ Public Sector (Central or State) or reputed organization for the last three years (minimum) i.e. for the Gregorian year 2017, 2018, 2019. Certificates from all principal employers of the bidder for providing satisfactory services with the No. of employees engaged in all three years i.e. 2017, 2018, 2019 is required.
- e. **Turnover:** The Bidders should have an average **turnover of Rs.50 Lakh (Rs.Fifty Lakh only)**, for minimum two financial years i.e. 2017-2018 and 2018-2019.
- f. **Character:** The contractor should not have been blacklisted ever by any previous employer.

## 21 DOCUMENTS SUPPORTING THE MINIMUM ELIGIBILITY CRITERIA

- (i) In proof of having fully adhered to the minimum eligibility criteria at 2(a), attested copy of Certificates of Incorporation issued by the respective Registrar of firms/Companies. The bidder should also submit EPF challans generated and paid along with the receipt supported by bank statement for last six months i.e. from 1.7.2019 to 31.12.2019 of all eligible personnel working in all organization/ Government institutions.
- (ii) In proof of having fully adhered to minimum eligibility criteria at 2(b), attested copies of PAN of firm, GST for services, EPFO,ESIC shall be acceptable.
- (iii) In proof of having fully adhered to minimum eligibility criteria at 2(c), the  
(a) affidavit with self-declaration/undertaking duly attested by notary/executive magistrate shall be acceptable.  
(b) Income Tax Returns for two financial years i.e. 2017-2018,2018-2019.
- (iv) In proof of having fully adhered to minimum eligibility criteria at 2(d), attested copies of experience certificates from all principal employers of the bidder for providing satisfactory services with the No. of employees engaged in all three years i.e. 2017, 2018, 2019 is required.

**3. EARNEST MONEY DEPOSIT (EMD):**

31 This bids should be accompanied by an EMD of **Rs. 50,000/-** (Fifty thousand only) in the form of Bank Guarantee of any nationalized bank. The validity of the Bank Guarantee must be up to 6 (six) months starting from the date of submission of the bids. The Bank Guarantee / Demand Draft shall be in favor of Director/Principal, Rajiv Gandhi Govt. Engineering College, Kangra at Nagrota Bagwan, HP.

32 The bids without Earnest Money shall be summarily rejected.

33 No claim shall lie against the Government / Department in respect of erosion in the value or interest on the amount of EMD

**34 EMD may be forfeited:**

- (i) If the bidder withdraws his bid during the period of bid validity specified by the bidder in the bid form; or
- (ii) In case of successful bidder, if the bidder
  - (a) Fails to sign the contract in accordance with the terms of the tender document
  - (b) Fails to furnish required performance security in accordance with the terms of tender document within the time frame specified by the Client.
  - (c) Fails or refuses to honor his own quoted prices for the services or part thereof.

**4. VALIDITY AND CURRENCY OF BIDS**

- 5.3 Financial bid envelope shall contain only financial bid in prescribed proforma duly filled and signed.
- 5.4 The Bid shall be submitted not later than **01.00 P.M of the last date of submission of the tender i.e. 31/01/2020** addressed to the Director-cum Principal, Rajiv Gandhi Govt. Engineering College, Kangra at Nagrota Bagwan, HP.
- 5.5 **Late Bids:** Any Bid received by the office after the deadline for submission of bids, as stipulated above, shall not be considered.
- 6. RIGHT OF ACCEPTANCE/REJECTION:**
- 6.1 The Director-cum-Principal reserves all rights to reject any or all bids without assigning any reason whatsoever and does not bind itself to accept the lowest or any specific bids. The decision of the Director/Principal (Competent Authority) in this regard shall be final and binding.
- 6.2 Any failure on the part of the bidder to observe the prescribed procedure and any attempt to canvass for the work shall render the bidder's bids liable for rejection.
- 6.3 The competent authority reserves the right to award any or part or full contract to any successful agency (ies) and also reserves the right to waive off any condition at its discretion and this will be binding on the bidders.
- 6.4 The Director-cum-Principal may terminate the Contract and performance guarantee forfeited if it is found that the Contractor is black listed on previous occasions by any of the Government Departments / Institutions / Local Bodies / Municipalities / Public Sector Undertaking etc.

### SECTION-3

#### GENERAL CONDITIONS OF CONTRACT

1. The successful bidder within fifteen days of the acceptance of the LOA shall execute a Performance Bank Guarantee in the form of a Bank Guarantee of any nationalized bank, a sum equivalent to 15% of the accepted annual contract value in favor of Director-cum-Principal, Rajiv Gandhi Govt. Engg. College Kangra at Nagrota Bagwan, Payable at Nagrota Bagwan, Kangra. Validity of the performance security shall be 1.5 years on signing of the agreement. In case of extension of contract, the bidder has to again execute the above Performance Bank Guarantee accordingly.
2. The Bank Guarantee can be forfeited by order of the competent authority in the event of any breach or negligence or non-observance of any terms/condition of contract or for unsatisfactory performance or for non-acceptance of the work order. On expiry of the contract, such portion of the said Bank Guarantee as may be considered by the competent authority sufficient to cover any incorrect or excess payments made on the bills to the firm, shall be retained until the final audit report on the account of firm's bill has been received and examined. On due performance and completion of the contract in all respects, the performance security Deposit will be returned to the contractor without any interest on presentation of an absolute **"No Dues Certificate"** in the prescribed form and upon return in good condition of any specifications, samples or other property belonging to the Client, which may have been issued to the contractor.

#### 3. SIGNING OF CONTRACT AGREEMENT

- 31 The successful Bidder shall enter into contract and shall execute and sign the Contract Agreement in accordance with the Articles of Agreement before commencement of the services.
- 32 Client shall prepare the draft Articles of Agreement in the Proforma included in this Document, duly incorporating all the terms of agreement between the two parties and send the same in duplicate to the successful Bidder for their concurrence.
- 33 The successful Bidder shall return the duly concurred copies of the draft Articles of Agreement within **Five (05) days** of receipt of the draft Articles of Agreement from Client, duly printed on the correct amount of stamp paper, duly adjudicated by the registrar of stamps where the contract is proposed to be executed.
- 34 The Director-cum-Principal, RGGEC Kangra at Nagrota Bagwan or the Client or a person authorized by him shall sign the Contract agreement and return a copy of the same to the successful bidder.

#### **4 SERVICES REQUIRED BY THE CLIENT**

- 4.1 The Contractor shall be providing mentioned services in Client's premises as per the details given in section on **Special Conditions of Contract and Schedule of Requirements** or any other location as required by the Client.

#### **6 CONTRACTOR'S OBLIGATIONS**

- 6.1 The Contractor shall provide mentioned services at Client's premises as per **Schedule of Work / Requirements** which may be amended from time to time by the Client during the Contractual period and it shall always form part and parcel of the Contract. The Contractor shall abide by such assignments as provided by the Client from time to time.
- 6.2 The Contractor shall provide mentioned services through its uniformed and trained personnel for the performance of its services hereunder and these personnel deployed shall be employees of the Contractor only and the Client shall not in any manner be liable.
- 6.3 The Client shall have the right, within reason, to have any personnel removed who is considered to be undesirable or otherwise and similarly the Contractor reserves the right to remove the any personnel with prior approval of the Client, emergencies, exempted.

- 10.1 After selection of the Successful bidder as Contractor, a price schedule shall be annexed to the Articles of Agreement according to which all payments shall be made to the Contractor by the Client for the manpower services.

- 11.2.2 The Contractor does not provide manpower services satisfactorily as per the requirements of the Client or / and as per the Schedule of Requirements
- 11.2.3 The Contractor goes bankrupt and becomes insolvent.

### **13. INSOLVENCY**

- (iii) If the contractor commits any breach of this contract not herein specifically proved for: Provided always that such determination shall not prejudice any right of action or remedy which shall have accrued or shall accrue thereafter to the client and provided also that the contractor shall be liable to pay the client for any extra expenditure, he is thereby put to but shall not be entitled to any gain.

## **SECTION-4**

### **SPECIAL CONDITIONS OF CONTRACT**

#### **1. THE SPECIAL CONDITIONS OF CONTRACT:**

Special conditions of contract shall supplement the “Instructions to the Bidders” as contained in Section 2 and General Conditions of the Contract (GCC) as contained in Section 3.

#### **2. INDEMNIFICATION:**

The successful bidder is solely liable to fully indemnify and keep Client indemnified against all losses/penalties/awards/decrees arising out of litigation/claims/application initiated against the Client on account of acts of omission/commission attributable to the Contractor and which are punishable under the provisions of various Central Labour and Employment Acts including the following Acts as amended from time to time. Client shall be vested with sole discretion to determine damages/ loss suffered on account of above from the dues payable from security deposit as performance Guarantee or from either the personal property of bidder or property owned by his firm/company by way of initiating suitable legal litigation against the Contractor at any point of time.

#### **3. LABOUR LAW COMPLIANCES**

- 3.1 The engagement and employment of labourers and payment of wages to them as per existing provisions of various labour laws and regulations is the sole responsibility of the Contractor and any breach of such laws or regulations shall be deemed to be breach of this contract. Client may ask the contractor to produce documents to verify that these provisions/laws are complied with by the contractor. Wages, EPF etc. shall be paid by the contractor in the workers bank account and EPF account respectively. Client shall not incur any liability or additional expenditure whatsoever for the personnel deployed. If the contractor fails to transfer the wages in their account, the client may transfer the wages in workers account directly.
- 3.2 The Contractor shall abide by all labour laws, laws related to EPF Organization, Workmen Compensation Act. The details of EPF contributions in respect of their deployed staff paid by contractor shall be submitted by the Contractor to Client every month along-with the bill. The Contractor shall abide including but not limited to, matters relating to timely payment of wages and allowances, payment of minimum wages, payment of overtime, grant of leave, payment of workmen’s compensation, working hours, safety, maternity benefits, holidays, framing of standing orders, disciplinary action against employees, payment of provident fund contributions, payment of gratuities and payment of bonuses.

**4. OFFICIAL RECORDS:**

- 4.1 The Contractor shall maintain complete official records of disbursement of wages / salary, showing specifically details of all deductions such as contract labour Act, EPF etc. in respect of all the staff deployed in Client's office.
- 4.2 The Contractor shall maintain a personal file in respect of all the staff who is deployed in Client's office. The personal file shall invariably consist of personal details such as name, address, date of birth, sex, residential address (Temporary / Permanent) and all grievances recorded by the staff vis-a-vis action taken etc.
- 4.3 The Contractor shall furnish an undertaking that within seven days of the close of every month they will submit to Client a statement showing the recoveries of contributions in respect of employees with Certificate that the same have been deposited with EPFO Commissioners.
- 4.4 Each monthly bill must accompany the:
- (a) List of employees with their date of engagement
  - (b) The amount of wages (The Contractor shall ensure that minimum wages are paid to all the employees with the benefit EPF.
  - (c) Copies of authenticated documents of payments of such contributions to EPFO.
  - (d) Declaration of the Contractor regarding compliance of EPF rules.
- 4.5 The Contractor shall also prepare a register indicating all payments / dues in respect of all the employees.

**1. DEPLOYMENT AND TENTATIVE REQUIREMENTS OF MANPOWER**

1.1 The tentative requirements of manpower shall be as under:

**2. PENALTIES**

- 2.1 The Contractor shall disburse minimum wages to its deployed manpower, latest by 5<sup>TH</sup> of every month and these wages must be paid in their bank account through on-line transaction or through RTGS failing which **penalty of Rs.200/- per day** will be imposed up-to 15<sup>th</sup> of the month and thereafter contract shall be liable to be terminated. Security Deposit / Performance Bank Guarantee shall be forfeited and Bank guarantee will be uncashed. The Client will have the power to pay these personnel directly from uncashed Security Deposit / Performance Bank Guarantee and will have the power to appoint any other agency for the manpower services at the risk and cost of the Contractor.
- 2.2 Whenever and wherever it is found that the assigned work is not performed up-to the entire satisfaction of the Client, it will be brought to the notice of Contractor by the Client and if no action is taken immediately, **penalty of Rs.1000/- per day per complaint** will be imposed by invoking penalty clause.
- 2.3 The Contractor has to maintain adequate number of manpower as per this contract and also arrange a pool of standby manpower. If the required number of workers are less than specified number as mentioned in the contract, a **penalty of Rs.500/- per absentee per day** shall be deducted from the bill(s) till the required number as per contract is provided.
- 2.4 In case the Contractor fails to fulfill the minimum statutory requirements (EPF) as per the conditions of the tender document and fails to produce the concerned documents, it shall be treated as breach of the Contract and the Contractor is liable to be blacklisted by the Client, in addition to forfeiting of the monthly bills and Performance Security Deposit.
- 2.5 In case of breach of any conditions of the contract and for all types of losses caused including excess cost due to hiring manpower services in the event of Contractor failing to provide requisitioned number of manpower, the Client shall make deductions at double the rate of hiring rate on 18orker18 basis from the bills preferred by the Vendor or that may become due to the Vendor under this or any other contract or from the security deposit or may be demanded from him to be paid within seven days to the credit of the Client.
- 2.6 If any of the contractor's employee is found without uniform on duty, a penalty of Rs.100/- will be imposed.

### 3. SCOPE OF WORK

- 3.1 The Contractor must provide salary slips (each month), EPF numbers and ESI Cards, duly activated, to all the deployed manpower at Client's office. The Contractor should also ensure that EPF statements to the deployed manpower are provided immediately after the EPF is deposited in their EPF account monthly. Any delay in submission of these records will force Client to deduct a proportionate amount from the bills, as decided by the competent authority of Client.
- 3.2 Contractor must employ adult and skilled personnel only. Employment of child labor shall lead to the termination of the contract at the risk and cost of the Contractor. Contractor shall deploy/engage reliable persons at Client's premises after **Proper Character and Police Verification** and impose any conditions as per prevailing contractual labor laws for such engagements, take disciplinary action or reward any person at work etc., at its sole costs, risks and responsibilities. Working days shall be six days in a week (Sunday off) and from 08:30AM to 05:00 PM with half an hour lunch break from 01:30 to 02:00PM. However, any other holiday may be denied in case of urgency of work. Working hours may also be adjusted in such a manner that cleaning work in the office/ class norms in the morning should be completed at least half an hour before start of office or teaching work. - 6) Cleaning sweeping, mopping with disinfectant stair cases, faculty and staff cabins, lobbies, entry gate, reception, pantries/kitchen, canteen, all ceilings, glass panes, Corridors Ceilings, Administrative Block, Office Rooms, Conference rooms, boy's and girls' hostels, trainees hostel, guest house, etc. It also includes cutting of grass, bushes, collection of dry leaves, cleaning of all open as well as close drains and cleaning of
