On the subject cited above, it is to inform you that the applications for Technical Education Scholarship Scheme for Degree/Diploma & ITI students are to be received online for the year 2023-24 from the eligible trainees/students on NSP Portal. The portal has been opened for the students and closing date for the submission of application by the students is 25/11/2023, Defective application verification date is 15/12/2023, Institute verification is 15/12/2023 & SNO Verification is till 26/12/2023 which have been uploaded on the NSP Portal. The heads of institutes are requested to make wide publicity of the schemes and advise the eligible students to visit NSP and register themselves on NSP. Detailed procedure for registration /verification/FAQs are available on the portal.

The scheme is applicable for following students against each category. If the number of students exceeds the budget available in each scheme, the scholarship shall be awarded on merit basis.

Instructions for the students to apply online:

Fresh students or students applying for the 1st time need to register on NSP Portal URL <https://scholarships.gov.in/> by providing accurate & correct information as per their documents.

The detailed procedure for registration is available on the home page of the portal as “Operational manual on functionalities of NSP” and “Standard Operating Procedures”.

Similarly institute can also register after filling KYC registration form available under “Institute Corner” after entering the correct AISHE/DISE/NCVT Code available with the institute (Codes can be seen under “Public Corner”-“Search for Institutes on NSP”).

There will be two step verification of the applications. 1st step verification will be at institute level by the INOs & 2nd Step verification will be at Directorate level by the SNO.

You are therefore directed to intimate the students to upload correct information alongwith documents required to verify the same.

Following documents may be required to be available with the students before applying for the scholarship.

1. Bonafide Himachali Certificate.
2. Cast certificate (SC.ST.ORB).
3. Valid BPL/IRDP certificate alongwith Income certificate from the competent authority such as Tehsildar/BDO etc.
4. Matriculation Certificate.
5. Last qualifying examination certificate.
6. Bank details viz, Account No, IFSC Code etc.
7. Aadhar Number/Card
8. Certificates/Documents as required on the portal to be uploaded.

Note:-I. Renewal candidate must have passed their **previous class/course result**. In case of renewal only those student can apply who had got the scholarship in previous year.

Note:-II. In case of students applying for Degree/Diploma Scholarship in renewal cases, it must be kept in view that those students who have applied offline for the previous year should apply only offline during the current year also.

You are, therefore, requested to make wide publicity among the students to get the benefit of scholarship. Please also ensure to register as

Institute Nodal Officer on the portal within a weeks time under intimation to this office as the dates have already been finalized & configured on the portal.

Please treat it as most important. Any laxity in the matter shall be viewed sersiously. Wrong information/incomplete information will liable to rejection of application.
