- i) Click on https://antiragging.in/affidavit\_registration\_disclaimer.html
- ii) It will open Undertaking registration form for colleges.
- iii) In this online form fill up step wise details viz. student's detail, parent's/guardian details, college and course details, check UGC regulations, fill confidential survey. (Name of college Director is Dr. Deepak Kumar, phone number is 9418459175 and land line number is 01892-249188)
- iv) Click on submit button, a reference ID will be generated, note it for future reference,
- v) Go to Undertaking dropdown menu on the same website.
- vi) Click on Download button.
- vii) Enter your reference number, Email-Id and registered mobile number.
- viii) Click on submit, a pdf file of filled anti-ragging affidavit will be generated.
- ix) Rename it with your name followed by your branch and semester e.g. if your name is Sanjay Kumar, branch ME and semester 1st then file name will be sanjaykumarME1.pdf
- x) Email this pdf file on antiragging 2025 rggec@gmail.com.
- xi) Save screen shot of the Anti-Ragging Affidavit reference ID.
- xii) At the time of submitting registration form for the session 2025-26, students have to mention his/her anti-ragging affidavit reference ID, on the space provided for the same. Also attach print out of the screen shot of the Anti-Ragging affidavit reference ID or mail received on your e-mail ID as a proof.
- xiii) It is important to note that without anti-ragging affidavit reference ID and its printed proof duly signed by student and his/her parents/guardians, your registration process will not be considered complete. Henceforth, treat it most important.
