Under Section 9 of Himachal Pradesh Technical University Act, 2014 and pursuant to the recommendations of Peer Team/ Inspection Committee, the Board of Affiliation hereby grants the provisional Affiliation/Extension of affiliation on 25th May, 2026 to **Rajiv Gandhi Govt. Engineering. College Kangra at Nagrota Bagwan, District Kangra. (H.P)** for conduct of following courses for the academic session 2026-27:-

The affiliation is subject to fulfillment of the following deficiencies in the Institution/college pointed out by the Peer Team/Inspection Committee in their report/ recommendations.

- The faculty to be appointed as per AICTE norms and cadre ratio to be maintained as per norms.
- More supporting staff /lab technicians to be appointed as per norms.
- Labs need upgrading in terms of equipment and proper maintenance.
- The computer systems need to be upgraded, and licensed software should be purchased as per All India Council for Technical Education norms.
- Institution is required to ensure the registration/participation of all students and faculty members on SWAYAM portal/ MOOCs/ NPTEL courses.
- Institute should encourage faculty and students to present research papers in National and International level.
- Institution is required to ensure conduct/participation in all academic activities i.e., Seminars, Workshops, Conferences, FDPs etc.

The above mentioned approval is further subjected to the following conditions failing which the process of disaffiliation will be initiated:

- a) No excess admissions shall be made by the Institution over and above the approved intake by the AICTE/HPTU.
- b) The institution will not close or start new course(s) or alter intake capacity of seats without prior approval of the AICTE/ HPTU.
- c) Institution shall not charge tuition and other fees, other than as prescribed by the Govt. of Himachal Pradesh / HP Technical University. No capitation fee, Industrial training fee, creation of examination centre fee, fine for attendance, etc. shall be charged from the students in any form.
- d) The institution shall comply strictly with the provisions made under the Anti-Ragging Regulation notified from time to time by the UGC/AICTE/PCI/HPTU/State Government for prevention and prohibition of ragging in Institution/College.
- e) The institute will follow the admission procedure, University Calendar, syllabus, examinations procedure and other norms/standards as laid down by the HPTU from time to time.
- f) Regarding this letter, the Institution, if so desires submit appeal for consideration by the Standing Appeal Committee within ten days from the date of issue of this letter as per provision in Himachal Pradesh Technical University, Ordinance No.61, Chapter -IV, Clause 9 (ix-x) and Schedule-V.
- g) As per the roster received from the State Govt. of HP the multiplication factor of 1.22 shall be followed to maintain the prescribed percentage of reservation of EWS. Therefore, the intake of seats for course with intake of 30, 40 and 60 would be increased to 37, 49 and 73 respectively.

Submission of compliance report is required in respect of above deficiencies along with documentary evidence within a period of two months from the date of issuance of this letter.

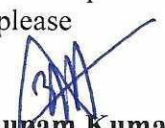
