6.7 Equipment

6.8 Warranty

- Minimum Three Years Comprehensive standard across all equipment.

7. Instruction regarding bid

All the pages of bid being submitted must be sequentially numbered by the bidder irrespective of nature of content of the documents. The offers submitted by email shall not be considered. No correspondence will be entertained in this matter.

8. Rejection

- b) Joint venture not allowed and No subletting of works by the contractor/firm is permissible.

9. Bid Opening Details:

- a) The Technical Bids shall be opened as per opening date & Time notified in the Notice in the office of the undersigned by the Committee authorized by the competent authority in the presence of such bidders who may wish to be present or their authorized representatives.
- b) The financial bids of only those bidders whose Technical Bids are qualified, shall be opened by the Committee authorized for the purpose.
- c) The date and time of opening of the financial bids shall be intimated to the technically qualified bidders through website of the college or by e-mail.

INFORMATION AND INSTRUCTIONS FOR TENDERERS

The tenderers are advised to study full tender document carefully before tendering and they shall be deemed to have fully acquainted themselves with the same.

1. The Tenderers should ensure that the RGGEC shall bear no responsibility for the lack of acquaintance of the site and other conditions or any information relating thereto, on their part. The consequences of the lack of any knowledge, as aforesaid, on the part of the tenderer shall be at their risk and cost and no charges or claims whatsoever consequent upon the lack of any information, knowledge of understanding shall be entertained or payable by the RGGEC.
2. The offer should be valid for 90 (Ninety) days from the last date for submission of tender.
3. The tender should be submitted in physical form in the office of Director-cum-Principal, RGGEC, Kangra and the same should be signed properly as laid down hereunder: -
 - a) If the tender is submitted by an individual, it shall be signed by the proprietor above his full name and full name of his firm with its current business address.
 - b) If the tender is submitted by a firm in partnership, it shall be signed by all the partners of the firm above their full name and current business addresses, or by a partner holding the power of attorney of the firm by signing the tender in which case a certified copy of the power of attorney shall accompany the tender. A certified copy of the partnership deed and current business address of all the partners of the firm shall accompany the tenders.
 - c) If the tender is submitted by a limited company or a limited Corporation, it shall be signed by a duly authorized person holding the power of attorney for signing the tender in which case a certified copy of the power of attorney shall accompany the tender. Such limited company or corporation may be required to furnish satisfactory evidence of its signature.
 - d) All witnesses and sureties shall be persons of status and their full names, occupation and addresses shall be stated below their signatures. All signatures affixed on each page in the tender will be dated.
 - e) The tender for the works shall not be witnessed by a tenderer or tenderers who himself/themselves has/have tendered or who may and has/have tendered for the same works. Failure to observe this condition shall render the tender of the tenderer tendering as well as of the witnessing the tender liable to rejection.
 - f) The earnest money deposit will be returned to the unsuccessful tenderers within 45 days after finalization of tender.
 - g) The earnest money of the successful tenderer will be returned after he deposits performance security in the shape of bank guarantee/FDR pledged in favor of The Director cum Principal RGGEC Nagrota Bagwan, Kangra HP @ 8% of the Total Quoted Value.
 - h) The performance security will remain with the institute for a period of 1 year commencing from the date of successful installation of the equipment.
 - i) The Director cum Principal, RGGEC, Nagrota Bagwan shall have the right of rejecting all or any of the tenders and may reduce the scope of work and also will not be bound to accept the lowest or any other tender and the Director Cum Principal, RGGEC decision in this regard shall be final and binding on all

tenderers.

- j) The tenderers shall not be entitled during the period of validity of their offers, to revoke or withdraw their tenders or vary any terms in regard thereof without the consent of the Director Cum Principal, RGGEC in writing. Tenderer shall get his earnest money forfeited for any violation of this clause.
- k) The tenderer will execute the work within 30 days from the date of issue of written order to commence the work. The Director cum Principal, RGGEC shall have a right to forfeit the earnest money deposited by the tenderer absolutely without prejudice to other rights and remedies available with RGGEC on the violation of this clause.
- l) The “Notice Inviting Tender” and this “Information and Instructions for Tenderer” shall form part of the Tender Documents.
- m) Any addendum/corrigendum issued before the date of opening of tender will form part of tender documents.
- n) Intending tenderers should visit the site, satisfy themselves regarding the site conditions, location of site, and collect all relevant information required before tendering for the work, tenderer shall be deemed to have full knowledge of the site, specifications and no excuse as regard to want of information or clarification shall be considered after the tender has been received. A certificate in this regards is to be necessarily uploaded in the technical bid.
- o) Terms of Payment:- 100% payment will be made to the supplier on successful completion of delivery and installation and commissioning of all the equipment at site as per the supply order placed by the respective units and certificate issued by Committee constituted for this purpose. The quality/ make, brand of equipment should be strictly as per financial quotation. No advance payment shall be released.
- p) The institute may waive off any minor infirmity, non-conformity, or irregularity in a bid that does not constitute a material deviation and that does not prejudice or affect the relative ranking of any bidder as a result of the technical and financial evaluation.

SCOPE OF WORK

The successful bidder shall be responsible for the complete execution of the work, including but not limited to the following:

1. Supply

The bidder shall supply all commercial-grade gym equipment, accessories, attachments, tools, consumables and other items as specified in Technical Specifications.

2. Transportation

The bidder shall transport all equipment to Rajiv Gandhi Government Engineering College, Kangra at Nagrota Bagwan, H.P., at his own cost, risk and responsibility.

3. Loading and Unloading

Loading, unloading, shifting at designated location and safe handling of all equipment at site shall be the responsibility of the bidder.

4. Installation

The bidder shall install all equipment at the locations identified by the Institute in accordance with the manufacturer's recommendations. The bidder without any additional cost shall supply all fasteners, anchor bolts, fittings and accessories required for proper installation.

5. Testing and Commissioning

After installation, each machine shall be tested and commissioned in the presence of the Institute's representatives. The equipment shall be handed over only after successful testing.

6. Calibration and Adjustment

Wherever applicable, the bidder shall carry out necessary calibration, alignment and adjustments before commissioning.

7. Demonstration

The bidder shall demonstrate the proper operation, safety features and maintenance procedures of each equipment to the satisfaction of the Institute.

8. Documentation

The bidder shall supply:

- User Manual
- Service Manual (where applicable)
- Warranty Cards
- Parts Catalogue (if available)
- Installation Report
- Commissioning Report

9. Warranty Support

The bidder shall provide comprehensive warranty support as specified in the tender document.

During the warranty period, all repairs, replacement of defective parts, labour, transportation and other incidental expenses shall be borne by the bidder.

10. Preventive Maintenance

The bidder shall carry out preventive maintenance visits during the warranty period at intervals recommended by the OEM or at least once every six months. Preventive maintenance reports shall be submitted to the Institute.

11. Breakdown Maintenance

During warranty period, any complaint lodged by the Institute shall be attended within **72 hours**.

Equipment remaining non-functional beyond the stipulated period shall be repaired or replaced by the bidder without additional cost.
